## ASSIGNMENT OF PATENTS

ASSIGNOR does hereby sell, assign and transfer unto ASSIGNEE, its successors, assigns and legal representatives, all right, title and interest in and to the U.S. patents identified and set forth on the attached Schedule A, together with all inventions and discoveries disclosed therein, and all improvements thereon, for all countries of the world, including the right to claim priority under the International Convention based on such patents, including without limitation any renewal, revival, continuation, divisional, and continuation-in-part thereof, and any substitute application therefor, and any and all patents which have issued, and any reissue, reexamination, and extension of the same (collectively the "Patents").

2. ASSIGNOR hereby authorizes and requests competent authorities to grant and issue any and all Patents to ASSIGNEE, as the assignee of the entire right, title and interest therein.

3. ASSIGNOR agrees further to execute upon request of ASSIGNEE such additional documents, if any, as are necessary and proper to secure patent protection on such

Patents throughout all countries of the world and to otherwise give full effect to and perfect the rights of the ASSIGNEE under this Assignment of Patents.

4. ASSIGNOR represents to ASSIGNEE that: (a) the Patents identified in Schedule A are owned of record by ASSIGNOR; (b) ASSIGNOR has not assigned or transferred to any third party (other than ASSIGNEE) any rights that ASSIGNOR may have in or to any of the Patents, in whole or in part, including without limitation by means of any security interest that may have been granted to a financial institution or other lender; and (c) ASSIGNOR is the sole and exclusive owner of all rights in and to the Patents, which Patents are not subject to any lien, claim, license, royalty arrangement or dispute.

5. This Assignment of Patents includes the right to file patent applications in any countries with respect to any of the Patents in ASSIGNEE's own name or such other name(s) as ASSIGNEE may choose, the right to claim for any and all damages by reason of past infringement of the rights so sold, assigned, and transferred, and the right to sue for and collect the same for ASSIGNEE's own use and enjoyment and for the use and enjoyment of its successors and assigns, the same to be held and enjoyed by ASSIGNEE, its successors and assigns, to the full end of the term thereof.

5. This instrument may be executed by facsimile signature and in one or more counterparts, each of which shall for all purposes be deemed to be an original and all of which shall constitute the same instrument.

6. This instrument shall be governed by the laws of the Commonwealth of Pennsylvania, without giving effect to the conflicts of law principles thereof.
