ASSIGNMENT

WE, Chad L. Robran and Douglas Parsell of 3650 Annapolis Lane, Suite 105, Plymouth, MN, 55447 and 327 Arlington Circle, Ridgeland, MS 39157, have invented a method and apparatus entitled DEVICE AND METHOD FOR PELVIC ELEVATION AND STABILIZATION OF SURGICAL PATIENT hereinafter called the “invention.”

Preferred embodiments of said invention are disclosed in a United States patent application now identified as File No. 19757.1 of the law firm of Workman Nydegger, 1000 Eagle Gate Tower, 60 East South Temple, Salt Lake City, Utah 84111, and filed in the United States Patent and Trademark Office as Serial No. 13/736,742 on January 8, 2013.


