**Assignment of Invention**

WHEREAS WE, **Bryan B. STONE, Benny K. MCDONALD, Allan J. ZADIRAKA and Rajani K. VARAGANI**, respectively, have invented certain new and useful improvements in **OXY-COMBUSTION COAL FIRED BOILER AND METHOD OF TRANSITIONING BETWEEN AIR AND OXYGEN FIRING**, for which a provisional patent application was filed on **April 14, 2008**, having Application No. **61/044,528**, and an application for Letters Patent was filed on **April 13, 2009**, having Application No. **12/422,685**;


