RECITALS

- A. The Assignor is the owner of the Patent, Patent applications, Trade Mark application, and Designs set out in Schedule 1 ("the Intellectual Property").
- B. The Assignor has agreed to sell, assign, transfer and set over to the Assignee, all the rights, title and interest in and to the Intellectual Property and the inventions and innovations described therein.
- C. To the best of the Assignor's reasonable knowledge, all of the Intellectual Property relevant to the Single Wheel Trolley and the Trolley for Transporting Loads is set out in Schedule 1 of this Deed.

- 2. The parties agree that the rights assigned herein include the right to make future applications for protection of the invention and innovations in the Intellectual Property, and the right to claim priority from any of the applications.

3. The Assignor shall, as and when requested by the Assignee, execute all documents and do such matters, acts and things as may be required by the Assignee to enjoy the full benefits of the rights hereby assigned and to facilitate the recording of the Assignee as the registered proprietor of the Intellectual Property in all jurisdictions including Australia, the United States of America, and before the International Bureau and the Community Design Office (OHIM).
