necessary to secure to ASSIGNEE its interest and title in and to said Improvements or any part(s) thereof, and in and to said several patents or any of them;

AND ASSIGNORS hereby covenant for themselves and their legal representatives, and agree with said ASSIGNEE, its successors and assigns, that it has granted no right or license to make, use, sell or offer to sell said Improvements, to anyone except said ASSIGNEE, that prior to the execution of this deed, its rights, title and interest in said Improvements had not been otherwise encumbered, and that ASSIGNORS have not and will not execute any instrument in conflict therewith;


