### ASSIGNMENT OF PATENT RIGHTS

"Disclosures" means all inventions, invention disclosures, and/or discoveries, for which (a) none of the foregoing have been described in or included in a patent application (in any country or jurisdiction) filed by Seller prior to the Effective Date and (b) are any of (i) owned by Seller, (ii) assigned to Seller, or (iii) subject to an obligation of assignment to Seller, as of the Effective Date.

#### NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

For good and valuable consideration, the receipt of which is hereby acknowledged, Assignor agrees to and does hereby irrevocably sell, assign, transfer and convey unto said Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest (i) in and to the Patents, the same to be held and enjoyed by said Assignee for its own use, and for the use of its successors, assigns, or other legal representatives to the end of the term or terms for which said Patents may be granted as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made; (ii) in and to causes of action and enforcement rights for the Patents including all rights to pursue damages, injunctive relief and other remedies for past and future infringement of the Patents; (iii) to apply in any and all countries for the world for patents; certificates of invention or other governmental grants for the Patents; (iv) in and to all inventions, invention disclosures, and discoveries described in any of the Disclosures; (v) in and to all rights to apply in any or all countries of the world for patents, certificates of invention and utility models, claiming any inventions, invention disclosures, and discoveries described in

any of the Disclosures; (vi) causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the rights described in the foregoing subsection (v), including, without limitation, all causes of action and other enforcement rights for (1) damages, (2) injunctive relief, (3) any other remedies of any kind for past, current and future infringement, and (4) rights to collect royalties or other payments under or on account of any of the foregoing. This Assignment shall be governed by, and construed in accordance with, the laws of the United States in respect to patent issues and in all other respects by the laws of the State of California, without giving effect to the conflict of laws rules thereof.
