Assignor further covenants that no instrument has been executed that is contrary to this Assignment nor has Assignor taken any action contrary to this Assignment nor will Assignor do so in the future.

Assignor hereby authorizes post-signature entry of the filing date and serial number assigned to the Application by the USPTO in the spaces provided above in order to ensure proper identification of the Application being assigned hereby.
