Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act.

FIRST: That the names and states of domicile of each of the constituent entities of the merger are as follows:

SECOND: That an Agreement of Merger between the parties to the merger has been approved, adopted, certified, executed and acknowledged by each of the constituent entities and in accordance with the requirements of subsection (b) of Section 18-209 of the Delaware Limited Liability Company Act.

THIRD: The name of the Corporation surviving the merger is RheoGene, Inc., a Foreign Corporation organized under the laws of the Commonwealth of Pennsylvania.

FOURTH: That the executed Agreement of Merger is on file at the principal place of business of the surviving foreign Corporation. The address of said principal place of business is 2650 Eisenhower Ave., Norristown, PA 19403.

FIFTH: That a copy of the Agreement of Merger will be furnished by the surviving foreign corporation, on request and without cost, to any member of any

domestic limited liability company or any person holding an interest in any other business entity which is to merge.

SIXTH: That the surviving foreign Corporation agrees that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of any domestic limited liability company which is to merge, irrevocably appointing the Secretary of State as its agent to accept service of process in any such action, suit or proceeding and the address to which a copy of such process shall be mailed to by the Secretary of State is 2650 Eisenhower Ave., Norristown, PA 19403.

SEVENTH: This Certificate of Merger shall be effective on July 31, 2003.
