**ASSIGNMENT AND RELEASE OF
SECURITY INTEREST
(Patent Release – Second Lien)**

April 30, 2013

This Assignment and Release of Security Interest (this “Release”) is dated as of the date first set forth above. Reference is hereby made to that certain Patent Security Agreement (Second Lien) (the “Patent Security Agreement”; capitalized terms used but not defined herein shall have the meanings given to them in the Patent Security Agreement) dated as of June 7, 2012, by Securus Technologies, Inc., a Delaware corporation located at 14561 Dallas Parkway, Suite 600, Dallas, TX 75254 (the “Grantor”), in favor of BNP Paribas located at 787 Seventh Avenue, New York, NY 10019, in its capacity as collateral agent pursuant to the Second Lien Credit and Guaranty Agreement (in such capacity, the “Collateral Agent”), recorded with the United States Patent and Trademark Office on June 7, 2012, at Reel/Frame No. 028334/0365.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby notifies, acknowledges and agrees with the Grantor that (i) the lien on and security interest in the Patent Collateral pledged and granted by the Grantor to the Collateral Agent, including, without limitation, the lien on and security interest in the patents listed on the attached Schedule A, is terminated, released and discharged fully, (ii) the Collateral Agent hereby terminates the Patent Security Agreement, (iii) the Collateral Agent hereby releases and forever discharges fully all of its right, title and interest in, to and under, and of any kind or nature in the Patent Collateral it may have been granted, assigned or conveyed pursuant to the Patent Security Agreement, including all Proceeds of the foregoing, including royalties, income, payments, claims, damages, and proceeds of suit, and all tangible property used to make the goods associated with any of the Patent Collateral, and (iv) any right, title or interest of the Collateral Agent in, to and under the Patent Collateral shall hereby cease and become void. The Collateral Agent hereby retransfers and reassigns to the Grantor, without representation or warranty, all of the Collateral Agent’s right, title and interest it may have in, to and under the Patent Collateral.

The Collateral Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
