2. **Wellstream International Limited** a company incorporated and registered in England and Wales with company number 04582101 whose registered office is at Wellstream House, Wincomblee Road, Walker Riverside, Newcastle Upon Tyne, NE6 3PF ("**the Assignee**")

Operative Clauses


1. In this Agreement the following words shall have the following meanings:

"the Inventions" means the inventions claimed in the Patent Applications and the Patents and all intellectual property rights in such inventions.

"the Patent Applications" means the patent applications details of which are at Schedule 1

"the Patents" Means the granted patents details of which are at Schedule 2

2. In consideration of the sum of £1 now paid by the Assignee to the Assignor (receipt of which the Assignor confirms) the Assignor hereby assigns to the Assignee its entire right, title and interest in and to the Patents, the Patent Applications and the Inventions including without limitation:
 - a. Its entire right to be absolutely entitled to any patent granted on any of the Patent Applications for the full term of such patents and its entire to apply for, be granted and hold patents for the Inventions in or for any part of the world (including without limitation its right and title to any and all future foreign or PCT applications and national/regional phase applications patents derived from any of the Patent Applications and the Patents and all future PCT applications as well as any and all divisional and continuation applications) and the right to priority;
 - b. the right to recover and take all such proceedings as may be necessary for the recovery of damages or other forms of relief in respect of all infringements of the Inventions and/or the Patent Applications and/or the Patents whether committed before or after the date of this Assignment.



3. The Assignor agrees that it will at the expense of Assignee, promptly execute sign all such instruments applications documents and do all such acts and things as may reasonably be required by the Assignee to enjoy the full benefit of the property and rights hereby assigned (including without limitation executing any and all forms required in connection with the filing and prosecution of patent applications and otherwise assisting with the prosecution to grant of the Patent Applications and any future applications claiming priority therefrom)
4. The Assignor hereby irrevocably appoints the Assignee as its Attorney in its name and on its behalf to execute and do any instrument or thing as may be required by the Assignee to enable it to enjoy the full benefit of the rights assigned by this Assignment and in favour of any third party a certificate signed by any Director or the Secretary of the Assignee that any instrument or act falls within such authority shall be conclusive evidence that such is the case.
5. The Assignee hereby accepts the assignment at clause 2 of this Assignment.
6. This Agreement shall be governed by and interpreted in accordance with the laws of England and the parties hereby submit to the exclusive jurisdiction of the English courts.




