## **RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS** (this "Release") is made as of March 28, 2013 ("Effective Date") by and between **MANUFACTURERS AND TRADERS TRUST COMPANY**, a New York corporation, with its principal office at 25 S. Charles Street, 12th Floor, Baltimore, Maryland 21201 ("Grantee"), and **SIGNAL PERFECTION, LTD.**, a Maryland limited company, with its principal office at Ste 1660, 7 Saint Paul Street, Baltimore, Maryland 21202 ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Patent and Trademark Agreement by and between Grantor and Grantee dated January 25, 2012 (the "Patent and Trademark Agreement"), Grantor granted to Grantee a continuing security interest in and to certain patents and/or patent applications, including those patents listed on Schedule A hereto (the "Patents"), and certain registered trademarks, including registrations and/or pending applications therefor, together with the goodwill of the business connected with the use of and symbolized thereby, including those trademarks listed on Schedule B hereto (the "Marks" which together with the Patents shall be collectively referred to herein as the "Intellectual Property"); and

**WHEREAS**, Grantor and Grantee entered into the Patent and Trademark Agreement pursuant to the terms and conditions of that certain Security Agreement by and between Grantors, those other parties signatory thereto and Grantee dated April 17, 2008 (the "Security Agreement");

**WHEREAS**, the Patent and Trademark Agreement was recorded with the United States Patent and Trademark Office ("PTO") on February 13, 2012, at Reel/Frame 4716/0574; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Patent and Trademark Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any patent or patent application, or trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Patents and Trademarks set forth on Schedules A and B (attached hereto), in any jurisdiction throughout the world, other than such filings made in the United States Patent and Trademark Office.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other

instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
