1. I, David W. Bogle, of 1354 Becca Teal Place, Round Rock, Texas 78681; U.S.A., have made a certain new and useful invention relating to


### **SYSTEM AND METHOD FOR DETECTING CONTAMINATION OF A CONVEYOR**

e. I acknowledge that this agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.


