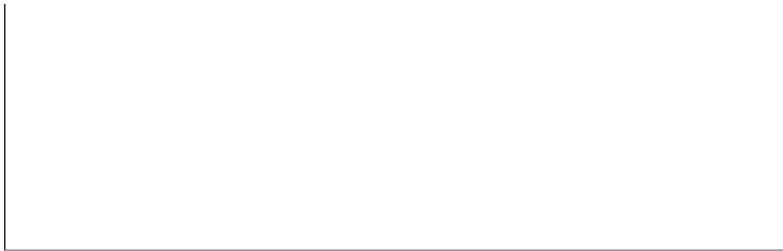

FURTHER, nothing contained herein shall be deemed to alter or amend the terms and provisions of that certain Asset Purchase Agreement dated as of March 8, 2013, by and between ASSIGNOR and ASSIGNEE (the “PURCHASE AGREEMENT”) and in the event of any conflict between the terms and provisions of this Assignment and the Purchase Agreement, the terms and provisions of the Purchase Agreement shall be deemed to govern and be controlling in all circumstances. This Assignment is executed pursuant to the Purchase Agreement and is entitled to the benefits and subject to the provisions thereof and shall bind and inure to the benefit of the parties thereto and their respective successors and assigns.
