ASSIGNMENT AGREEMENT

IN THIS AGREEMENT, made and entered into as of the 15th day of MAY, 2013 (Effective Date), 3VNET, INC., a Delaware corporation having offices at 2400 Sand Lake Rd., Suite 600, Orlando, Florida, 32819 (3VNET), and AUTOMATED CONTROL TECHNOLOGY PARTNERS, INC., a Florida corporation having offices at 2400 Sand Lake Rd., Suite 600, Orlando, Florida, 32819 (ACTP), agree as follows:

1. 3VNET owns all right, title, and interest in and to the patents and patent application identified on SCHEDULE A, attached hereto and made a part hereof, the inventions disclosed and claimed therein, and all worldwide patents and applications that rely on the patents and patent applications identified on SCHEDULE A for priority (the patents, patent applications and inventions disclosed are collectively referred to herein, for convenience, as the PATENTS).
2. ACTP desires to acquire and 3VNET is willing to assign to ACTP all of 3VNET's right, title, and interest in and to the PATENTS and any inventions disclosed and claimed therein.
3. 3VNET hereby transfers, grants, conveys, assigns, and relinquishes exclusively to ACTP all of 3VNET's right, title, and interest in and to the PATENTS, the inventions claimed therein, and all accrued causes of action for damages for infringement thereof.
4. 3VNET acknowledges the receipt and sufficiency of the good and valuable consideration received from ACTP.
5. 3VNET will execute and deliver to ACTP the Assignment in ATTACHMENT A hereto, and, from time to time after the date hereof upon the request of ACTP, such further conveyance instruments as may be necessary or desirable to evidence more fully the transfer of ownership of all the PATENTS to ACTP, or the original ownership of all the PATENTS on the part of 3VNET, to the fullest extent possible. 3VNET further agrees to provide testimony in connection with any proceeding affecting the right, title, interest, or benefit of ACTP in and to the PATENTS and to perform any other acts deemed reasonably necessary to carry out the intent of this Agreement. ACTP will reimburse 3VNET for any and all costs reasonably incurred by 3VNET in performance under this paragraph.
6. In furtherance of this Agreement, 3VNET hereby acknowledges that, from the Effective Date forward, ACTP has succeeded to all of 3VNET's right, title, and standing to receive all rights and benefits pertaining to the PATENTS, institute and prosecute all suits and proceedings, and take all actions that ACTP, in its sole discretion, may deem necessary or proper to collect, assert, or enforce any claim, right, or title of any kind under any and all of the PATENTS, whether arising before or after the Effective Date, defend and compromise any and all such actions, suits, or proceedings relating to such transferred and assigned rights, title, interest, and benefits, and do all other such acts and things in relation thereto as ACTP, in its sole discretion, deems advisable.
7. 3VNET represents and warrants that no consents of any other parties are necessary or appropriate under any agreements concerning any of the PATENTS

in order for the transfer and assignment of any of the PATENTS under this Agreement to be legally effective.

8. 3VNET represents and warrants that, to the best of 3VNET's knowledge, upon consummation of this Agreement, ACTP shall have good and marketable title to the PATENTS, free and clear of any and all liens, mortgages, encumbrances, pledges, security interests, licenses, or charges of any nature whatsoever.
9. This Agreement shall inure to the benefit of, and be binding on, the parties hereto together with their respective legal representatives, successors, and assigns.
10. This Agreement shall be governed by and construed in accordance with the laws of the State of Florida (excluding conflicts of law rules) and of the United States.
11. This Agreement merges and supersedes all prior and contemporaneous agreements, assurances, representations, and communications between or among the parties hereto concerning the matters set forth herein.

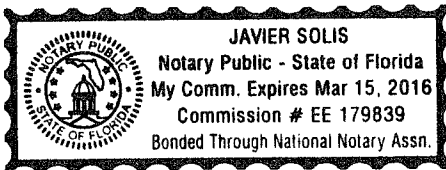

AUTOMATED CONTROL TECHNOLOGY PARTNERS, INC., a Florida corporation having offices at 2400 Sand Lake Rd., Suite 600, Orlando, Florida, 32819 (ACTP), desires to own 3VNET's entire right, title, and interest in and to the inventions, in all countries throughout the world, and in and to the PATENTS.

AND, 3VNET HEREBY further covenants that 3VNET has the full right to convey the interest assigned by this Assignment, 3VNET will take all action and execute all documents necessary to perfect the interest assigned hereby, and 3VNET has not executed and will not execute any agreement in conflict with this Assignment;

AND, 3VNET HEREBY further covenants and agrees that 3VNET, through its officers and employees, will, without further consideration, communicate with ACTP, its successors and assigns, any facts known to 3VNET and its officers and employees respecting the invention and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the invention in said ACTP, its successors and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths, and generally do everything possible to aid ACTP, its successors and assigns, to obtain and enforce proper patent protection for the invention in the United States and any foreign country, it being understood that any expense incident to the execution of such papers shall be borne by ACTP, its successors and assigns.

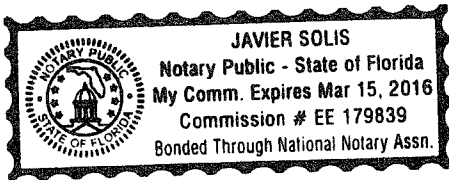
