AND, furthermore we covenant and agree with said Assignee, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by me and that full right to convey the same as herein expressed is possessed by me.

I hereby appoint SHFL entertainment, Inc. and its attorneys Attorney in Fact to prosecute this application and all future continuation applications, continuations-in-part applications, divisional applications, reexamination or reissue thereof and any and all future related applications and issued patents thereof.

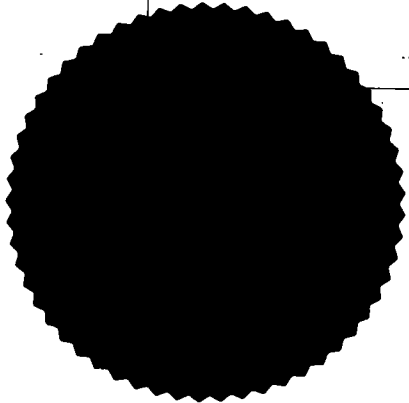
