J. van der Bruggen** of Amundsenlaan 55, 5623 PN Eindhoven, the Netherlands (hereinafter referred to as "Inventors"), hereby sell, assign and transfer unto **STAHL International B.V.** of Sluisweg 10, 5145 PE Waalwijk, the Netherlands, its successors and assigns, (hereinafter referred to as "Assignee"), the entire interest for the United States of America and all foreign countries, including all rights of priority under the international conventions and treaties, in and to a certain invention or improvement known as "Process for the Preparation of Multifunctional Polycarbodiimides Which are Used as Crosslinking Agents" and described in an application filed in the United States Patent and Trademark Office on January 28, 2013, as Attorney Docket No. 31310-1006, and given U.S. Patent Application Serial No. 13/751,463 which claims priority of International Application Serial No. PCT/NL2011/050397 known as "Process for the Preparation of Multifunctional Polycarbodiimides Which are Used as Crosslinking Agents" filed June 6, 2011, which claims priority of Netherlands Patent Office patent application No. 2005163 known as "Process for the Preparation of Multifunctional Polycarbodiimides Which are Used as Crosslinking Agents" filed July 28, 2010, and in all Letters Patent of the United States and all foreign countries which may or shall be granted on said invention, or any parts thereof, or on said application, or on any provisional, utility, divisional, continuing, continuation-in-part, reissue, reexamination or other applications based in whole or in part thereon. As used herein, the terms "Inventors" and "Assignee" shall include such parties and their heirs, administrators, estates, successors and assigns of every kind.


