I will communicate to Assignee any facts known to us respecting any improvements; and, at the expense of Assignee, we will testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, make lawful oaths and declarations and generally take all reasonable steps to vest title in Assignee and to aid Assignee to obtain and enforce proper protection for said invention in all countries.
