## PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of May 28, 2013 by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent (in such capacity, “**Agent**”) for certain financial institutions.

### WITNESSETH:

WHEREAS, Agent and Hearthside Food Solutions, LLC (“**Grantor**”), were parties to that certain Patent Security Agreement dated as of June 8, 2012 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Agent in the Patent Collateral (as defined therein) (the “**Patent Collateral**”) as security for certain obligations owing by Grantor to Agent, including the registered Patents set forth below.

WHEREAS, the Assignment was recorded by the Patent Division of the United States Patent and Patent Office on June 8, 2012 at Reel 028349, Frame 0739; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor’s right, title and interest in, to and under certain Patent Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in and lien on all of Grantor’s right, title and interest in, to and under the following (collectively, the “**GT Patent Collateral**”):

- a. the Patents set forth on Exhibit A hereto;
- b. all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the foregoing; and
- c. all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the GT Patent Collateral.
