## NUNC PRO TUNC PATENT ASSIGNMENT

**WHEREAS**, AT&T Labs, Inc., (hereinafter referred to as "AT&T Labs"), a Delaware corporation with an address of 9505 Arboretum Blvd., Austin, TX 78759-6392, and AT&T Intellectual Property I, L.P., (hereinafter referred to as "AT&T Intellectual Property I"), a Nevada Partnership, with an address of 675 W. Peachtree Street, Atlanta, GA 30308 (AT&T Labs and AT&T Intellectual Property I, hereinafter collectively referred to as ("the Parties")) agree that Thoms Joseph Killian, Norman Loren Schryer, and Lorinda L. Cherry (the "Inventors") listed on application serial number 13/517,545, filed on June 13, 2012, and entitled "Method And System For Verifying The Status Of 911 Emergency Telephone Services", was under an obligation to assign all right, title, and interest to the inventions described therein to AT&T Intellectual Property I, or a predecessor in interest to AT&T Intellectual Property I, at the time of such inventions; and

**WHEREAS**, to the extent AT&T Labs owns the Inventor's right, title, or interest in or to the inventions, patents, and applications, AT&T Labs desires to assign any such of the Inventor'ss right, title, or interest to AT&T Intellectual Property I including the right to sue for past infringement; and

**NOW, THEREFORE**, for and in consideration of Ten United States Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, AT&T Labs assigns to AT&T Intellectual Property I *nunc pro tunc*, all of the Inventor's right, title and interest including the right to sue for past infringement in and to said application and all patent which may be granted therefore, and all divisions, reissues, reexaminations, and continuations thereof; and AT&T Labs hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all patents for said inventions, or patents resulting there from, insofar as AT&T Lab's interest in the Inventor's rights is concerned, to AT&T Intellectual Property I. AT&T Intellectual Property I retains all rights, title and interest in said application from the inventors other than the Inventor's. This Nunc Pro Tunc does not transfer the right, title or interest of AT&T Intellectual Property I from any other inventor(s) to AT&T Intellectual Property I.
