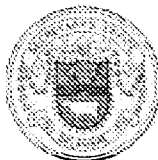

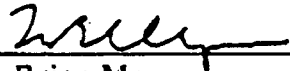
FIRST: The name of the Limited Partnership is The Kendall Company L P
