**RELEASE OF SECURITY INTEREST IN PATENTS**

**THIS RELEASE OF SECURITY INTEREST IN PATENTS** (this “Release”) is made as of March 5, 2013 in favor of MEDTECH PRODUCTS, INC., a Delaware corporation (“Grantor”) by CITIBANK, N.A., in its capacity as administrative agent (the “Administrative Agent”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

**WHEREAS**, Grantor and the Administrative Agent entered into that certain ABL Security Agreement by and between Grantor, the Administrative Agent and the other parties thereto dated January 31, 2012 (the “Security Agreement”);

**WHEREAS**, pursuant to the Security Agreement, Grantor granted to the Administrative Agent a lien on and security interest in all of its right, title and interest in, to and under certain intellectual property and, in connection therewith, entered into that certain Patent Security Agreement dated January 31, 2012 (the “Patent Security Agreement”) for the purpose of recording such security interest with respect to the patents of Grantor with the United States Patent and Trademark Office;

**WHEREAS**, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on February 3, 2012, at Reel 027645, Frame 0862;

**WHEREAS**, Grantor has entered into an Agreement Regarding Asset Purchase by and between Prestige Brands Holdings, Inc., the Grantor and Shock Doctor, Inc. dated March 5, 2013 (the “Agreement Regarding Asset Purchase”), pursuant to which Grantor assigns certain of its intellectual property, including those patents set forth on Schedule A attached hereto (collectively, the “Released Patents”), to Shock Doctor, Inc.; and

**WHEREAS**, Grantor has requested that the Administrative Agent release its lien on and security interest in the Released Patents.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates, cancels and releases any and all security interests it has against the Released Patents and (ii) re-assigns to Grantor any right, title and interest it may have in, to and under the Released Patents.

The Administrative Agent shall, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.



This Release shall be governed by and construed in accordance with the laws of the State of New York.
