ASSIGNMENT

WHEREAS We, **Wangdong CHEN, Tuo SHU and Yongwang PEI** and of **21A Science Plaza International Science Park, No.1355 Jinjihu Avenue, Suzhou, Jiangsu 215021, P.R. China** (hereinafter referred to as "ASSIGNORS") have invented certain new and useful improvements in:
