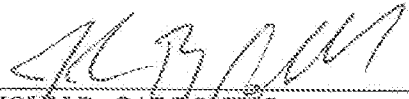

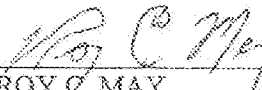
ASSIGNMENT

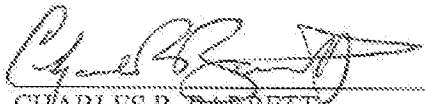
