Other provisions / Autres dispositions

Les autres dispositions décrites à la rubrique 7 des statuts de fusion de la société et à l'annexe jointe, sont, par les présentes, modifiées par l'ajout de la version anglaise suivante :

The other provisions described in Section 7 of the Articles of Amalgamation of the corporation and the attached schedule referred thereto are hereby amended by adding the following English version:

"The directors of the corporation may, without authorization of the shareholders:

- a) borrow money on the credit of the corporation;
- b) issue, reissue, sell, pledge or hypothecate debt obligations of the corporation;
- c) subject to the provisions of the *Canada Business Corporations Act*, give a guarantee on behalf of the corporation to secure performance of an obligation of any person; and
- d) mortgage, hypothecate, pledge or otherwise create a security interest in all or any property of the corporation, owned or subsequently acquired, to secure any obligation of the corporation.

The directors may, by resolution or by by-law, delegate the exercise of the powers listed above to any director, a committee of directors or any officer to the extent and in the manner provided by that resolution or by-law.

* * * * *

The directors may appoint one or more additional directors, who shall hold office for a term expiring not later than the close of the next annual meeting of shareholders, but the total number of directors so appointed may not exceed one third of the number of directors elected at the previous annual meeting of shareholders."
