Be it know that for good and valuable consideration, the receipt of and sufficiency whereof are hereby acknowledged, Assignors have sold, assigned and transferred and do hereby sell, assign and transfer to Assignee, its successors and assigns, their entire undivided right, title and interest in and to the said Assigned Inventions, whether not patentable, and any and all other patents, inventions, registrations or patent rights related thereto including, without limitation, all reissues, reexaminations, extensions, renewals, divisions, continuations, and continuations-in-part of any patents or patent rights relating thereto, along with all foreign counterparts of the foregoing in the United States of America, Mexico and Canada, to the full end of their respective terms, and further including all rights of action and damages for past infringement thereof, to be held and enjoyed by Assignee, its successors and assigns, the same as it would have been held and enjoyed by Assignors, if this assignment and sale had not been made.

Assignors hereby covenant and warrant that the Assignors have the full right and authority to convey the Inventions assigned by this assignment. Assignors, jointly and severally, hereby represent and warrants that there are no rights or interests outstanding inconsistent with the rights and interests granted herein and that Assignors will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and Assignors bind themselves and their respective officers, directors, members, managers, legal representatives, successors or assigns, as the case may be, to execute and deliver to Assignee, its successors and assigns, any further documents or instruments and do any and all further acts that may be necessary to vest in Assignee, its successors and assigns, all rights to the Inventions herein conveyed, and to enable Assignee, in its sole and nonreviewable discretion, to secure letters of patents with respect thereto.

Assignors further covenants and agrees, in consideration of the premises, that each will, at any time upon request, communicate to Assignee, its successors and assigns, any facts relating to the said Inventions and the history thereof known to each or their respective successors and assigns, and that each will testify as to the same in any proceeding when requested to do so by the said Assignee, its successors and assigns. The Assignors agree to and will perform the acts mentioned herein without the requirement of any additional consideration.

The undersigned Assignors hereby grants the law firm of Woodard, Emhardt, Moriarty, McNett & Henry, LLP attorneys, the power to insert on this Assignment any further identification that may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document. Assignors hereby authorize and request that any and all patents based on the Inventions issue to the Assignee, its successors in interest, its assigns, and/or its legal representatives.
