ASSIGNOR hereby covenants that no assignment, sale agreement or encumbrance has been or will be made or entered into which would conflict with this assignment.

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to the APPLICATION and the invention described therein, any patent applications claiming priority to the APPLICATION, and any patents issuing from said applications as may be known and accessible to ASSIGNOR and will testify as to the same in any interference, litigation, or proceeding related thereof and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce the APPLICATION, any patent applications claiming priority to the APPLICATION, and any patents issuing from said applications and said equivalents thereof which may be necessary or desirable to carry out the purpose thereof.


