WITNESSETH: That

WE are joint inventors of a certain new and useful improvement and invention in

**SPACER GRIDS WITH SPRINGS HAVING IMPROVED ROBUSTNESS**

for which we have prepared and filed a United States Provisional Application for Patent on April 17, 2012, having U.S. Application Serial No. 61/625164, and for which we have prepared and executed an application for Letters Patent of the United States on January 22, 2013, having U.S. Application Serial No. 13/746099; and

I hereby request the Honorable Commissioner of Patents and Trademarks of the United States to issue the Letters Patent in accordance with this instrument.


