

Lelli, Jr.**, a United States citizen, residing at 1006 Old Post Road, Mamaroneck, NY 10543, **Mark Rosenblatt**, a United States citizen, residing at 1520 York Avenue, Apt. 21B, New York, NY 10025, **Rohini Rao**, a United States citizen, residing at 3 Heron Court, Plainsboro, NJ 08536 and **Nadee Nissanka**, a United States citizen, residing at 313 Patterson Avenue, Osprey, FL 34229, have invented certain new and useful improvements in **MAGNETIC CONTROL OF EYELID POSITION** for which PCT International Application Serial No. **PCT/US11/065544** was filed on **December 16, 2011**;

AND WE HEREBY covenant and agree that we will communicate to the said **Cornell University**, its successors, legal representatives, and assigns, any facts known to us respecting said improvements and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Cornell University**, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
