countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said Improvements to the said **Hanchett Entry Systems, Inc.**, its successors, legal representatives and assigns, in accordance with the terms of this instrument.



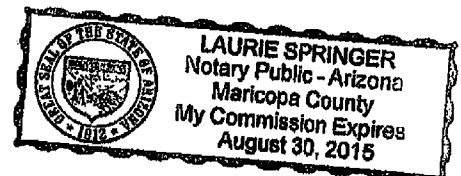
