## ASSIGNMENT

This Intellectual Property Assignment (the "Assignment") is made effective as of June 12, 2013 ("Effective Date") by and between Tyche Entertainment, LLC. ("Tyche") and Yehia Awada ("Awada") (together the "Parties" and each individually a "Party").

WHEREAS, pursuant to an Agreement dated May 16, 2008 by and between Tyche and Yehia Awada, an individual (recorded in the USPTO at Reel/Frame 020951/0903), Tyche was granted all right, title and interest in and to United States Patent No. 6,206,780 titled "MULTI POKER" ("the '780 Patent");

WHEREAS, Awada, whose post office address is P.O. Box 30245, Las Vegas, NV 89173 is desirous of acquiring the entire interest in and to the '780 Patent and any reissue or reexamination thereof, to be obtained therefor; and

WHEREAS, Awada owns a majority interest in Tyche and is authorized to act as its Manager, and therefore has actual authority to act on Tyche's behalf for all purposes.

UPON SAID CONSIDERATION, Tyche represents and warrants to Awada that: (i) Tyche is the owner of certain rights, title and interest in and to the '780 Patent; (ii) Tyche has not assigned, transferred, licensed, pledged or otherwise encumbered its interest in and to the '780 Patent and (iii) Tyche has full power and authority to enter into this Assignment and to make the assignment set forth herein. Tyche hereby agrees that it will, at any time upon request, without further or additional consideration, but at the expense of Awada, execute such additional assignments and other writings and do such additional acts as said Awada may deem necessary or desirable to perfect the Awada's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, non-provisional, continuation, continuation-in-part, divisional, renewal, reissued or extended Letters Patent of the United States, or of any and all foreign countries, on said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.

UPON EXECUTION, Tyche will not claim to possess any right, title or interest in and to the '780 Patent and will take no actions jeopardizing the existence or enforceability of the '780 Patent or Assignee's rights therein. Tyche authorizes and request the Commissioner of Patents and Trademarks of the United States and of all foreign countries to issue any subsequently filed reexamination, reissue, or other application, to Awada, its successors and assigns, as the assignee of their entire interest in the '780 Patent.

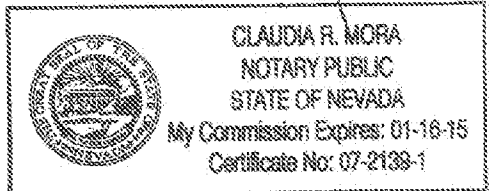

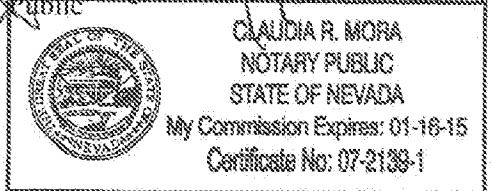
