WHEREAS, JinHo PARK and KwanSoo KIM, hereinafter called the "Assignors", have made the invention described in the United States patent application entitled **ORGANIC LIGHT EMITTING DISPLAY DEVICE AND METHOD OF MANUFACTURING THE SAME**, executed by Assignors on the same date as this Assignment;
