ASSIGNMENT

Awada hereby agrees that it will, at any time upon request, without further or additional consideration, but at the expense of Gaming Development, execute such additional assignments and other writings and do such additional acts as said Gaming Development may deem necessary or desirable to perfect the Gaming Development's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, non-provisional, continuation, continuation-in-part, divisional, renewal, reissued or extended Letters Patent of the United States, or of any and all foreign countries, on said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.

UPON EXECUTION, Awada will not claim to possess any right, title or interest in and to the '780 Patent and will take no actions jeopardizing the existence or enforceability of the '780 Patent or Assignee's rights therein. Awada authorizes and request the Commissioner of Patents and Trademarks of the United States and of all foreign countries to issue any subsequently filed reexamination, reissue, or other application, to Gaming Development, its successors and assigns, as the assignee of their entire interest in the '780 Patent.
