TERMINATION OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This Termination of Security Interests in Patents and Trademarks, dated as of June 18, 2013, is made by C3 Capital Partners, L.P., a Delaware limited partnership ("C3") and Eagle Fund I, L.P., a Missouri limited partnership ("Eagle Fund") and collectively, with C3, the "Lender", under that certain Trademark, Patent and Copyright Security Agreement, dated as of April 4, 2006 between Traeger Pellet Grills LLC, a Florida limited liability company (the "Grantor") with an address of 9445 SW Ridder Road, Wilsonville, Oregon 97070 and the Lender (as amended, supplemented or modified and in effect from time to time, the "IP Security Agreement").

WHEREAS, pursuant to the IP Security Agreement the Grantor granted a security interest to the Lender in certain Trademarks and Patents including the Trademarks and Patents set forth on Exhibit A thereto (the "IP Collateral"); and

WHEREAS, the IP Security Agreement was recorded with the (i) Trademark Assignment Division of the United States Patent and Trademark Office on July 26, 2006 at Reel 3355, Frame 0753 and (ii) Patent Assignment Division of the United States Patent and Trademark Office on July 26, 2006 at Reel 018006, Frame 0020; and

WHEREAS, the Lender has agreed to terminate and release its security interest in all of such Trademarks and Patents, including, without limitation, the Trademarks and Patents identified on Schedule A attached hereto, being the same Trademarks and Patents set forth on Exhibit A to the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP Security Agreement in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Lender in the IP Collateral.
