- II. Inventions, invention disclosures and discoveries described in any of the Assigned Patents;
- III. Rights to apply in any or all countries of the world for any of the Assigned Patents and the inventions, invention disclosures and discoveries therein;
- IV. Causes of action (whether currently pending, filed or otherwise) and other enforcement rights under, or on account of, any of the Assigned Patents and/or the rights described in Paragraph 2.2(b), including, without limitation, all causes of action and other enforcement rights for (i) damages, (ii) injunctive relief, and (iii) any other remedies of any kind for past, current and future infringement; and
- V. Rights to collect royalties or other payments under or on account of any of the Assigned Patents and/or any of the foregoing.

AND Assignor hereby agrees to execute without further consideration any further documents and instruments which may be lawful and proper in the prosecution of the Assigned Patents, and which may be desirable or necessary to secure to Assignee its rights, title and interest in and to said Assigned Patents;

AND Assignor hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or other governmental grants or issuances that may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.



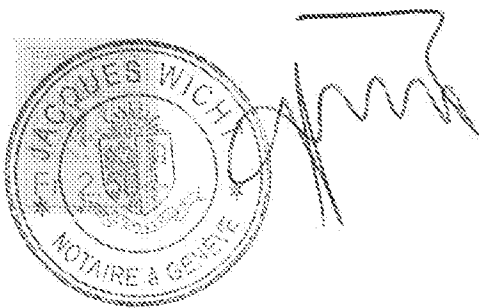
