ASSIGNMENT

WHEREAS the Government of the United States of America entered into a contract numbered **F19628-00-C-0002** with **MIT**, as Contractor, which contract provides that as to all discoveries, inventions, or improvements made or first reduced to practice in the performance thereof and not covered or to be covered by applications for Letters Patent filed by the Contractor, the Government of the United States shall be entitled to an assignment of the entire right, title, and interest therein, reserving to the Contractor, however, a nonexclusive, revocable, royalty-free license therein;

WHEREAS **Allan Heff** was employed by the Contractor and during the course of his employment made an invention entitled **COMPACT AEROSOL SAMPLER**, which invention forms a part of the aforesaid contract; and

WHEREAS the Contractor has signified its intention not to file an application for Letters Patent on the aforesaid invention;

NOW, THEREFORE, to all whom it may concern, be it known that for and in consideration of the premises and other valuable considerations, I, **Allan Heff**, the inventor and **MIT**, the Contractor, by its duly authorized officer or agent, have sold, assigned, and transferred, and by these presents do sell, assign, and transfer unto the said Government of the United States, as represented by the Secretary of the Air Force, the entire right, title, and interest throughout the United States of America, its territories and dependencies, and all foreign countries, in and to the said invention entitled **COMPACT AEROSOL SAMPLER** described in the specification executed by me on or about the 8 day of September 2005, preparatory to obtaining Letters Patent of the United States therefore and all Letters Patent issuing thereon and any continuations, divisions, and reissues or extensions thereof, reserving to the Contractor a nonexclusive, revocable, royalty-free license to make, use and/or sell the subject matter of said invention described in the aforesaid specification and in any patent or patents which may issue thereon and any continuations, divisions and reissues or extensions thereof without the payment of royalties thereon, which license shall be assignable to the successor of that part of the Contractor's business to which it pertains; we do hereby authorize and request the Commissioner of Patents to issue the said Letters Patent to the Government of the United States of America, as represented by the Secretary of the Air Force, and his/her successors, as the assignee of the said entire right, title and interest in and to the same for the sole use, except as aforesaid for the full term or terms for which said Letters Patent and any continuations, divisions, and reissues or extensions thereof are or may be granted as fully and entirely, except as aforesaid, as the same would have been held by **Allan Heff** and **MIT** had this assignment not been made; and I, **Allan Heff**, the inventor,

hereby agree to execute any and all applications for Letters Patent, both domestic and foreign, and to furnish all data and documents and to execute any papers which may be necessary for the preparation and filing of such applications, except it shall be understood that I shall not be subject to any out-of-pocket expense relative to such action.

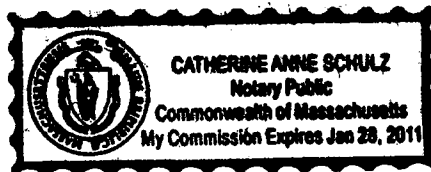




