**FINAL DECREE AND ORDER CLOSING CHAPTER 11 CASES**

Upon consideration of the Motion<sup>2</sup> of FastShip, Inc., *et al.* (the "Debtors") for Entry of Final Decree and Closing of Chapter 11 Cases; and it appearing that due and adequate notice has been provided; and it appearing that the estates of the above-captioned debtors were substantively consolidated for administrative purposes only; and after due consideration and deliberation and sufficient cause appearing therefor, it is hereby:

ORDERED, that the Motion is granted; and it is further

ORDERED, that the Plan has been substantially consummated, as all property to be transferred under the plan has been transferred and distribution under the Plan has commenced; and it is further

ORDERED, that pursuant to Bankruptcy Code § 350(a), Bankruptcy Rule 3022, and Local Rule 5009-1(a), Case Nos. 12-10968 (FastShip, Inc.), 12-10970 (FastShip Atlantic, Inc.), and 12-10971 (Thornycroft, Giles & Co., Inc.) are hereby closed; and it is further
