## PATENT ASSIGNMENT AGREEMENT

This Patent Assignment Agreement (this "**Patent Assignment Agreement**") is entered into as of October 14, 2008 by and between Renovis, Inc. a Delaware corporation with a place of business at Two Corporate Drive, South San Francisco, California 94080 ("**Assignor**") and Nathaniel Heintz, an individual having an address at 441 Fowler Avenue, Pelham Manor, New York ("**Assignee**").

WHEREAS, Assignor is the owner of the entire right, title and interest in and to:

U.S. Patent Application Serial No. 10/494,248 entitled "Method for isolating cell-type specific mRNAs" and filed with the U.S. Patent and Trademark Office on August 16, 2004 as a pending national stage entry application claiming priority to and the benefit of PCT/US02/34645 (the "**Patent Pending**"); and

WHEREAS, Assignee is desirous of acquiring the exclusive and entire right, title and interest in and to the Patent Pending.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:

1. Assignment. Assignor hereby, irrevocably and without reservation assigns, transfers and conveys to Assignee all right, title and interest in and to the Patent Pending.

2. Binding Agreement. The terms and covenants of this Patent Assignment Agreement shall inure to the benefit of Assignee and its successors and assigns, and shall be binding upon Assignor and his heirs, executors, administrators and other legal representatives.

3. Miscellaneous. This Patent Assignment Agreement shall be governed by the laws of the State of California, without reference to conflict of laws principles. Any failure to enforce any provision of the Patent Assignment Agreement shall not constitute a waiver thereof or of any other provision. This Patent Assignment Agreement may not be amended, nor any obligation waived, except by a writing signed by both parties. If any provision of this Patent Assignment Agreement is held by a court of competent jurisdiction to be unenforceable, then such provision shall be eliminated or limited to the extent required by applicable law and this Patent Assignment Agreement, as so modified, shall remain enforceable in accordance with its terms.
