

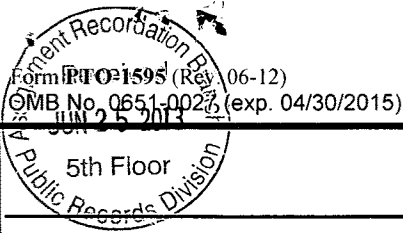

ASSIGNMENT
