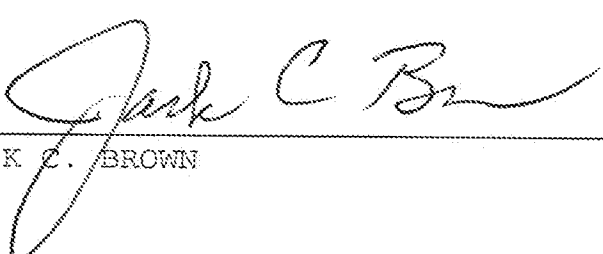
WHEREAS, WATERBOY SPORTS, LLC, hereinafter referred to as assignee, is desirous of acquiring the same.

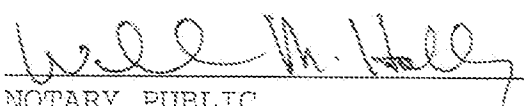
