ASSIGNMENT OF PATENT APPLICATIONS



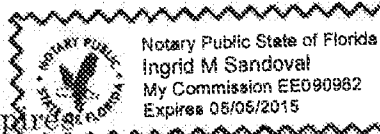



