ASSIGNOR requests the Commissioner for Patents to issue any Letters Patent of the United States which may be issued for said invention to ASSIGNEE, its legal representatives, successors, and assigns, as the sole owner of the entire right, title, and interest in and to said patent and the invention covered thereby.

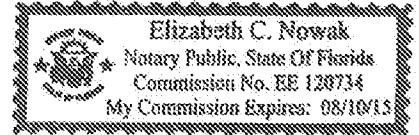
