At any time hereafter, Assignor shall, upon the Assignee's written request, take any and all reasonable steps and execute, acknowledge and deliver to the Assignee any and all further instruments reasonably necessary to vest all right, title and interest in and to the Intellectual Property more effectively in the Assignee.

3. This Agreement will be governed by and construed under the laws of the State of Delaware without regard to conflicts of laws principles that would require the application of any other law. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.

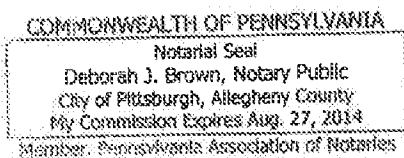

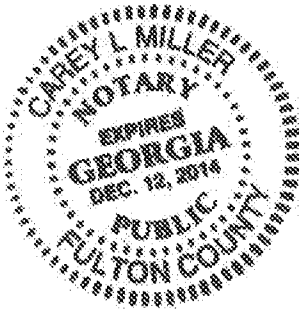
