INVENTION ASSIGNMENT

WHEREAS, Assignors believes themselves to be the original, first and/or sole inventors of the Invention disclosed and claimed in Exhibit A; and

WHEREAS, Logan Outdoor Products, L.L.C. ("Assignee") desires to acquire by formal, recordable assignment the entire right, title, and interest in and to said Invention, and said Patent Application in the United States and throughout the world.

NOW, THEREFORE, in consideration of good and valuable consideration rendered by Assignee:

1. Assignment. Assignor hereby grants and assigns unto Assignee, any right, title, and interest in the invention, including any and all patent applications based upon it. - (b) it has not sold or transferred the Invention to any third party;

- (d) it does not believe that the Invention has been taken from any third party without authorization (e.g., a knowing copy of another company's invention);


- (e) it does not know of any permissions that have to be obtained in order for this assignment to be completed;
- (f) the Invention was not conceived or created in the course and conduct of Assignor's employment by a third party.

4. Agreement to cooperate. The Parties agree that they are subject to the personal jurisdiction of such courts for the purposes of any such lawsuit or action.

This assignment and agreement shall be binding upon any and all heirs and legal representatives of Assignors.
















