ASSIGNMENT

WHEREAS, We, **Paul M. Lesley, Larry J. Pacey, and Norman R. Wurz**, have invented certain new and useful improvements in the following: “**GAMING MACHINE**” for which we have made application for United States Letters Patent; and

We also hereby sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world, including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries; and

We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

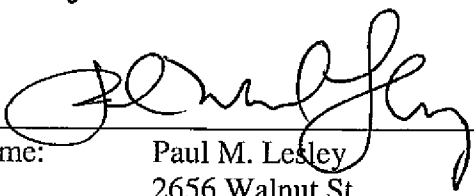

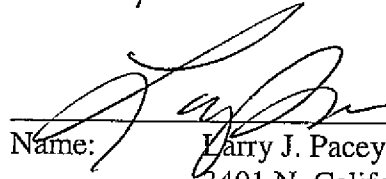

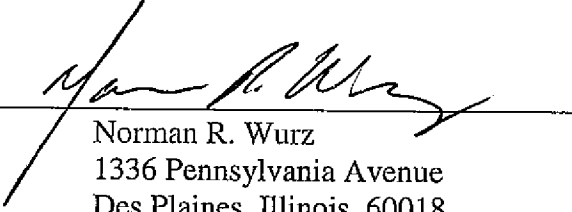
