# RESTATED ARTICLES OF INCORPORATION

The undersigned certifies that:

1. He is the **president** and the **secretary** of Pro Softnet Corporation, a California Corporation.
2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

- First:** The name of this corporation is IDrive Inc.
- Second:** The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporation Code.
- Third:** The total number of shares of stock in which the corporation shall have authority to issue is one thousand (1000). All such shares are to be without par value and are to be of one class.
3. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the board of directors.
  4. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 1000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
