ASSIGNMENT

WHEREAS, Joshua L. DeWard; Steven L. Brown; Kenneth Schofield; and Niall R. Lynam, residing at 32 East 19th Street, Holland, Michigan 49423; 13096 Lake Shore Drive, Grand Haven, Michigan 49417; 4793 Crestridge Court, Holland Michigan 49423; and 248 Foxdown, Holland, Michigan 49424, respectively (hereinafter referred to as Assignors), have invented certain new and useful improvements in a ACCESSORY MODULE FOR VEHICLE for which an application for United States Letters Patent was filed on August 11, 2005, and assigned Serial No. 11/201,661.

Assignors hereby authorize and request the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said Assignee as the owner of the entire right, title and interest in and to the same, for the sole use and behoof of said Assignee, its successors and assigns.


