ASSIGNMENT

WHEREAS, we, Todd P. Beach, of Encinitas, California, Peter L. Larsen, of San Marcos, California, and Bing-Ling Chao, of San Diego, California, have invented a certain invention as described in the following patent application:

We confirm that at the time the invention was made, we were under an obligation to assign the invention to Taylor Made Golf Company, Inc.
