NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer, convey and deliver unto Assignee, its successors and assigns forever, all of Assignor's rights, title and interest in, under, and to the Patents, together with all of Assignor's right to all income, royalties, damages, and payments, now or hereafter due and payable, and in and to all causes of action, either in law or in equity, and the right to sue, counterclaim and recover for past, present, and future infringement of the rights assigned or to be assigned hereunder, as fully and entirely as the same would have been held and enjoyed by the Assignor if this sale and assignment had not been made.

Assignor hereby reaffirms its representations and warranties applicable to the Patents as set out in the Asset Purchase Agreement, dated June 28, 2013 by and among Assignor, VALIANT PRODUCTS, LLC, a Pennsylvania limited liability company and f/k/a THE EX ONE COMPANY, ALVARO CARRARO, ZB INNOVATIONS, LLC a Texas limited liability company, and Assignee (the "**Asset Purchase Agreement**").

Assignor binds itself, its successors and assigns to warrant and forever defend title in and to the Patents unto Assignee, its successors and assignees, against any and every person whomsoever lawfully claiming or to claim the same or any part thereof, and as part of said warranty binds itself, its successors and assigns, to indemnify and hold Assignee harmless from any and all Costs (as that term is defined in the Asset Purchase Agreement), incurred by Assignee for breach of any warranty expressed in this Assignment of Patents Agreement, such indemnity to be in accordance with the terms of the Asset Purchase Agreement. In the event of a conflict between the terms and conditions of this Assignment of Patents Agreement and the terms and conditions of the Asset Purchase Agreement, the terms and conditions of the Asset Purchase Agreement shall govern, supersede and prevail.

Following the execution hereof, at the request of Assignee, Assignor, as applicable, shall deliver any further instruments of transfer and take all reasonable action as may be necessary or appropriate to carry out more effectively the provisions of this Assignment of Patents Agreement and to establish and protect the rights created in favor of the Assignee hereunder.
