LIMITED POWER OF ATTORNEY

PEAK SUN SILICON CORPORATION, a Delaware corporation, and PEAK SUN MATERIALS CORPORATION, an Oregon corporation (collectively, the “Debtors”), hereby irrevocably appoint XSI INTERNATIONAL CORPORATION, a British Virgin Islands business company (“Buyer”), as the true and lawful attorney of Debtors with respect to those certain personal property assets (the “Collateral”, as more specifically described in Exhibit “A” attached hereto) that Buyer purchased at that certain public auction sale, dated May 24, 2013 (the “Sale”), with full power of substitution for and on behalf of Debtors and in its name, and to take any action to preserve, maintain, protect or enforce the rights and interests of Debtors with respect to the Collateral. Such actions include, but are not limited to, the right to:

- (a) enforce, cure any default or otherwise act with respect to any contracts, or any other agreements pertaining to or affecting any of the Collateral;
- (b) take all such action and to execute all such documents as Buyer deems necessary or desirable to operate or preserve or protect the Collateral; and
- (c) sue for, demand or collect any sums owing to Debtors with respect to the Collateral.


The power so vested in Buyer is one coupled with an interest and will be irrevocable, except by written instrument executed by and between Buyer and Debtors. Notwithstanding the foregoing, Buyer is under no obligation to exercise any of the foregoing rights or take any action necessary to preserve any right in any Collateral against any other person, and Buyer, to the extent permitted herein or by applicable law, may exercise any of the foregoing rights without incurring any responsibility or liability to Debtors or any other person and without in any way affecting any obligations of Debtors to Buyer.

This Power of Attorney shall be governed by and construed under the laws of the State of California.



EXHIBIT "A"

DESCRIPTION OF COLLATERAL

The personal property assets ("Collateral") include, but are not limited to, (i) the intellectual property ("Intellectual Property") as more particularly described in Exhibit "1" attached hereto, (ii) any supplements, derivatives, developments, or updates of or relating to the Intellectual Property which may be created by Debtors so long as the Loans remain outstanding ("Supplemental Intellectual Property"), (iii) the bank accounts standing in the name of Debtors, including without limitation, the Union Bank accounts; (iv) all rights and benefits pursuant to that certain Confidential Agreement of Settlement and Release, dated July 12, 2010, by and between, among others, Peak Sun Silicon Corporation and SML Associates, a California corporation ("Lord Settlement Agreement"), (v) all rights and benefits pursuant to that certain agreement related to the installation of equipment, and for services to be provided related to the production of product for sale to customers at a location in Taiwan, Republic of China ("Taiwan OEM Agreement"), (vi) all rights and benefits pursuant to that certain Evaluation License and Option Agreement by and between Peak Sun Silicon Corporation and Jinzhou New Century Quartz (Group) Co., Ltd. ("Evaluation License"), and (vii) any other personal property owned by Debtors and which Debtors may assign and grant a security interest in without breaching its agreements with the State of Oregon Department of Energy ("ODOE"), whether now existing or hereafter from time to time created and whether now owned or hereafter from time to time acquired (and, to the extent not yet in existence or acquired, hereby assigned and conveyed by way of present assignment of future interests), whether tangible or intangible, wherever the same may be located and whether or not subject to the California Commercial Code (the "Code"), and all products and proceeds thereof, including without limitation, all of the following (capitalized terms used in this Section without definition shall have the respective meaning ascribed to such terms in the Code): (a) all Accounts; (b) all Chattel Paper; (c) all money and all Deposit Accounts, together with all amounts on deposit from time to time in such Deposit Accounts; (d) all Documents; (e) all General Intangibles, including all intellectual property, Payment Intangibles and Software; (f) all Goods, including Inventory, Equipment and Fixtures, including without limitation, any Goods, Inventory, Equipment and Fixtures located anywhere other than the Premises (as that term is defined in the Trust Deed); (g) all Instruments; (h) all Investment Property; (i) all Letter-of-Credit Rights and other Supporting Obligations; (j) all Records; (k) all Commercial Tort Claims; and (l) all Proceeds and Accessions with respect to any of the foregoing.

INTELLECTUAL PROPERTY

The intellectual property rights owned, or licensed by Peak Sun Silicon Corporation and/or Peak Sun Materials Corporation, existing as of the date of the public sale on May 24, 2013, are part of the Collateral and include, but are not limited to:

1. U.S. Patent Application 12/750,543 entitled "Tetrahalosilane Converter" relating to methods, in the production of silicon, to convert a tetrahalosilane to a trihalosilane, and related rights to file the claims set forth in the application in PCT countries, and certain other countries;
2. U.S. Patent #8,029,756 entitled "Closed-Loop Silicon Production" relating to a closed loop silicon production method and system, and related rights to file the claims set forth in the application in PCT countries, and certain other countries;
3. A perpetual, nonexclusive, paid-up sublicense, under Sublicense Agreement dated July 12, 2010, from SML to make, use, and sell the technology covered by U.S. Patent 7,790,129 in connection with bromosilane technology;
4. Process Flow Diagrams ("PFD"), Piping and Instrument Drawings ("P&ID"), and other engineering drawings, calculations, data, cost estimates, project schedules, and other confidential information relating to the construction of a polysilicon production facility ("Pilot Plant") on the California's site in Millersburg, Oregon, preserved as "confidential trade secret information"; and
5. Trademark applications for "Peak Sun" (US filing Serial No. 77/436171) and "Peak Sun Silicon" (US filing Serial No. 77/436163) filings in the U.S. and in various other countries required to be used in interstate commerce with "pure non-metallic silicon sold in granular form".
6. All "trade secret" and other proprietary information of the company related to the production of high purity (a) polysilicon, and (b) Phosphorous Oxychloride.
7. All trade names and trademarks owned and/or used by the company in connection with the said high purity polysilicon and Phosphorous Oxychloride.
