## **RELEASE OF SECURITY INTEREST IN PATENTS**

July 16, 2013

WHEREAS, QS WHOLESALE, INC., a California corporation (as successor by merger to Quiksilver Americas, Inc.), QUIKSILVER, INC., a Delaware corporation, DC SHOES, INC., a California corporation, and MERVIN MANUFACTURING, INC., a California corporation (each individually, a "Grantor" and collectively, the "Grantors") granted a security interest (the "Security Interest") in certain Patent Collateral to BANK OF AMERICA, N.A., a national banking association, as collateral agent (the "Collateral Agent"), as set forth in that certain Patent Security Agreement, dated as of October 27, 2010 by the Grantors in favor of the Collateral Agent (as amended, amended and restated, restated, supplemented or otherwise modified and in effect from time to time, the "Patent Security Agreement"), which was recorded with the United States Patent and Trademark Office on November 20, 2010, at Reel 025411 and Frame 0398. Capitalized terms used herein and not defined herein shall have the meanings assigned to such terms in the Patent Security Agreement;

WHEREAS, the Collateral Agent has been requested to release its Security Interest and reassign its interests in the Patent Collateral, including those Patents identified in Exhibit A attached hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

(A) The Collateral Agent hereby (i) terminates and releases the Patent Security Agreement and fully discharges the Collateral Agent's Security Interest in the Patent Collateral, including, but not limited to, the Patents and patent applications identified in Exhibit A; and (ii) reassigns, transfers and conveys to the applicable Grantor, without any representation, warranty or recourse of any kind, any and all of the Collateral Agent's right, title and interest in and to the Patent Collateral, effective as of the date set forth above.


(B) The Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given. The Collateral Agent shall, at the Grantors' sole cost and expense and at any of the Grantor's reasonable request, execute, acknowledge and deliver to the Grantors all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such Security Interest.
